It falls under Work Package 6 (WP6), which focuses on Impact Maximisation and specifically relates to Task 6.1, which focuses on building the InnWater Communication and Dissemination (C&D) ecosystem.

INTRODUCTION

Task 6.1 of the Work Package 6 is dedicated to building InnWater Communication and Dissemination (C&D) ecosystem.

The first step was to create the Communication and Dissemination strategy, a key document explaining the strategy chosen to communicate on the project and disseminate its outcomes (D6.1)¹. The strategy details how the communication and dissemination activities are carried out during the project and beyond, answering: “who (target audience), receives what (key messages), when (time planner) and how (tools and channels used)?”.

Deliverable D6.3 *Communication and Dissemination report and monitoring #1* is now the opportunity to take stock on the communication activities of InnWater, after the first 18 months of the project (March 2023 – August 2024).

This document will be updated at the end of the project (M36 – February 2025).

The overall **objectives of the InnWater C&D strategy** are to:

- Communicate and disseminate InnWater progress, results and outcomes
- Maximize the impact of the project
- Ease the transition from raising awareness on water governance to transferring InnWater results and outcomes to the targeted audiences
- Supporting the Pilot sites community (WP5) in their C&D activities
- Provide tailored recommendations to the different targeted audiences
- Provide guidelines with good practices for project partners to promote a gender-sensitive project communication.

This first report mainly focuses on Communication activities. The Dissemination will grow along as the results of InnWater are delivered and will be reported at the end of the project.

InnWater communication aims at promoting the project and its results, targeting at multiple audiences beyond the project own’s community (gathered in the networks of the InnWater partners and in the pilot site community). It includes, citizen, water managers, associations, SMEs, and researchers

InnWater **communication objectives** are to :

- Inform and reach out to targeted audiences about the project, its challenges and what it will bring to their everyday life, and ensure they are engaged;
- Pay attention to any behavioral differences between male and female targeted audiences;
- Clarify the common view on the project’s objectives and outcomes to agree on a unified and consistent message for all the project partners;
- Ease the transition from raising awareness on water governance to transferring InnWater results and outcomes to the targeted audiences;
- Support the Pilot sites community in their C&D activities.

Structure of the deliverable

The structure and organization of activities related to C&D are presented in section I of this document.

The internal communication is dedicated to ensure smooth collaboration and exchange of information between partners of the project on its progress and main news. Activities dealing with the internal communication level are reported in section II and focus on the materials and support provided to partners to promote InnWater progress and results.

The external communication aims at reaching stakeholders of the project and engage with them. Activities related to the external communication level are described in section III and refer to the channels and specific documents developed to reach the above-mentioned objectives. Dissemination activities are presented in section IV.

Section V presents the work undertaken to liaise project activities with other initiatives and networks (i.e. WaterGovernance2027 Synergy Group, INBO, OECD).

Finally, section VI focusses on the specific KPIs set to globally monitor the project C&D activities.

1. STRUCTURE OF THE ACTIVITIES

1.1 The Communication and Dissemination strategy

The Deliverable 6.1 *InnWater multi-level Communication and Dissemination strategy and plan V#1* was delivered in August 2023. It explains the strategy chosen to communicate on the project and disseminate its outcomes, and aims at ensuring the targeted audiences are reached through the lifetime of the project and beyond.

This document also shows how Communication and Dissemination activities take into consideration gender equality, especially by working on the way partners communicate using gender sensitive language.

C&D activities are led by OiEau but all InnWater partners play an important role and are fully part of the Communication and dissemination success of the project. Partners are expected to use their work, experience and networks to:

- communicate on the project
- participate in social media and website writing
- promote the project in all relevant events and activities
- provide appropriate information to the workforce and identify opportunities for the project.

To do so, OiEau, as WP6 leader, also attends meetings of the other WPs, to make sure that C&D objectives is part of all the activities of the project on the one hand, and gather an overall view of which topics can be used for C&D on the other hand.

The last part of the strategy is dedicated to explain how the C&D activities will be monitored. The monitoring is based on Key Performance Indicators (KPI). To regularly collect inputs from partners, an Excel file is used for them to report their C&D activities.

1.2 A Communication & Dissemination work force

As described in the MS12 *InnWater C&D work force set-up*, a structure and procedures have been set to facilitate the work on communication and dissemination with all the partners.

Indeed, a workforce has been established, composed of at least one contact per InnWater's organizations. Their mission is to ensure that information on the activities and progress of the project are given and spread in due time, and to ensure InnWater results are promoted in their own networks.

An email distribution list has been created: wp6-innwater@oieau.fr

This workforce, chaired and moderated by OiEau, is responsible of:

- organising the work to be done for communication and dissemination activities in relation with all the partners
- monitoring progress and assessing the impacts of the actions
- identifying possible risks and proposing mitigation solutions in close collaboration with the Project Coordinator
- chairing the WP6 workforce meetings.

This work force meets every month to discuss all WP6 related topics.

1.3 Planning to write new posts and articles

To ensure a permanent flow of WP6 communication and dissemination and regularly promote the project's activities, a general planning has been. For the first year, it informed on the date partners were expected to provide content and write posts for social media (Table 1). Guidelines for social media and a template to write short news article (available on the project platform) were prepared by OiEau.

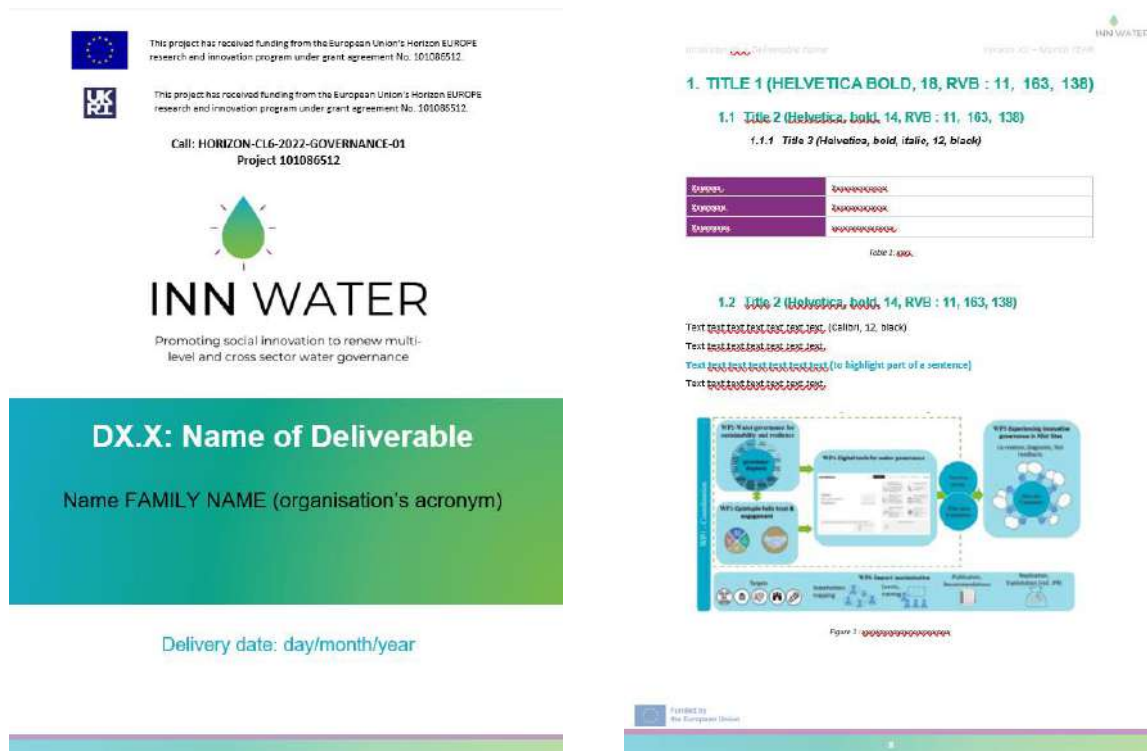


Figure 1: Templates for Word documents

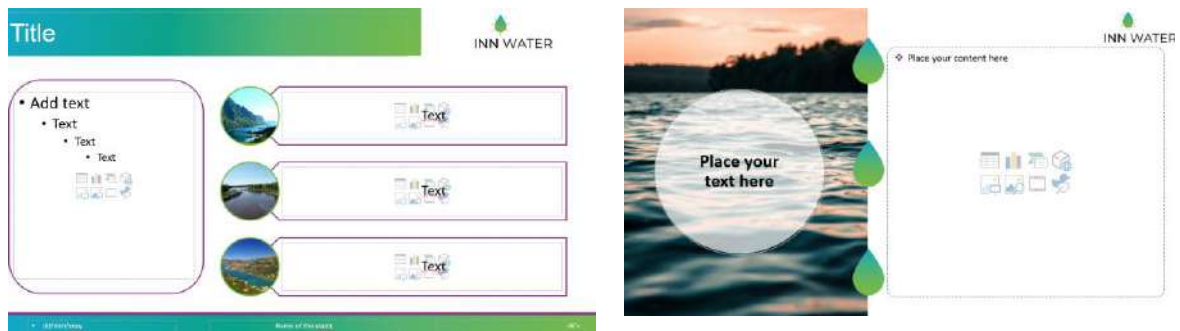


Figure 2: Templates for PowerPoint documents

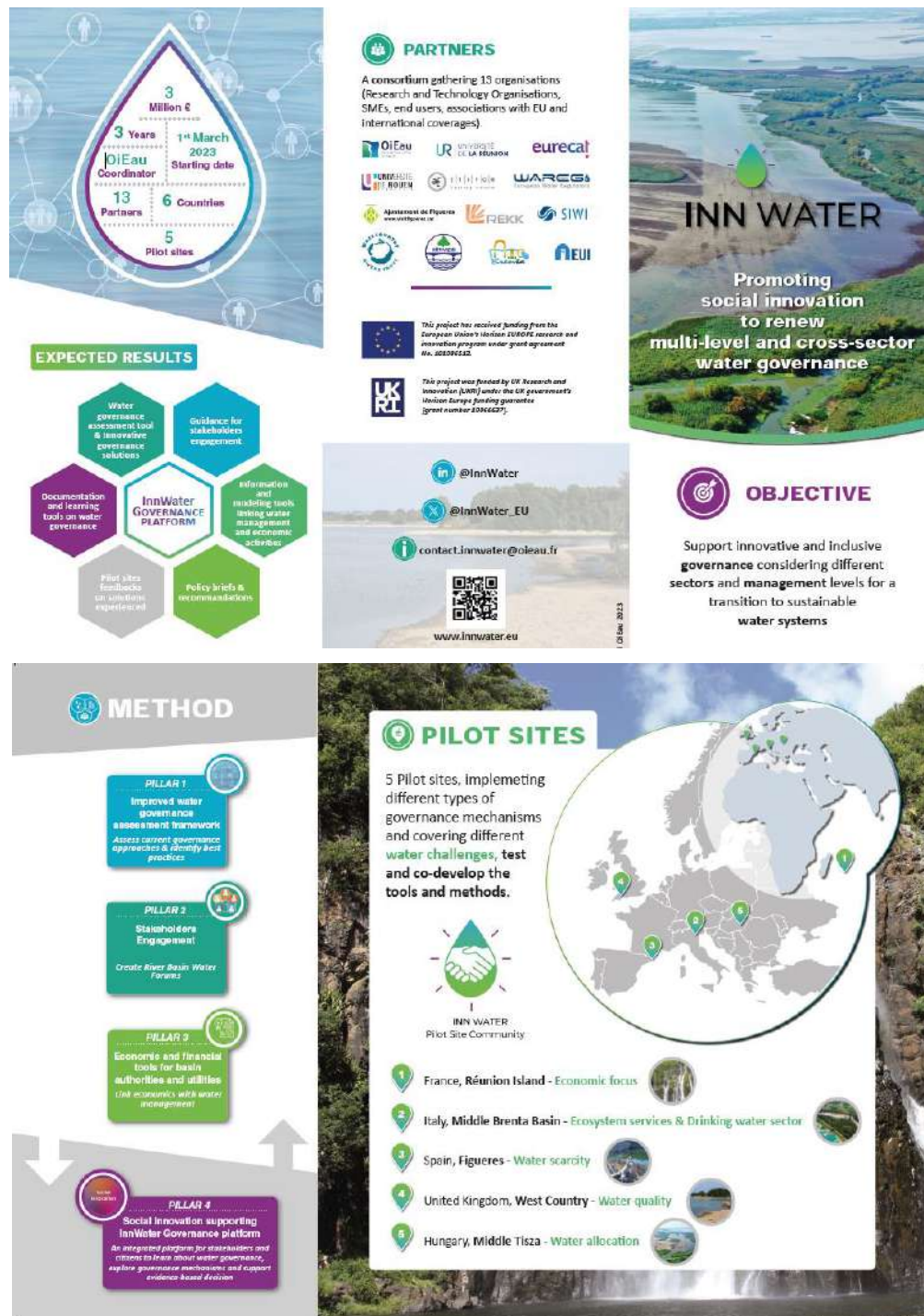


Figure 3: InnWater leaflet – Final version

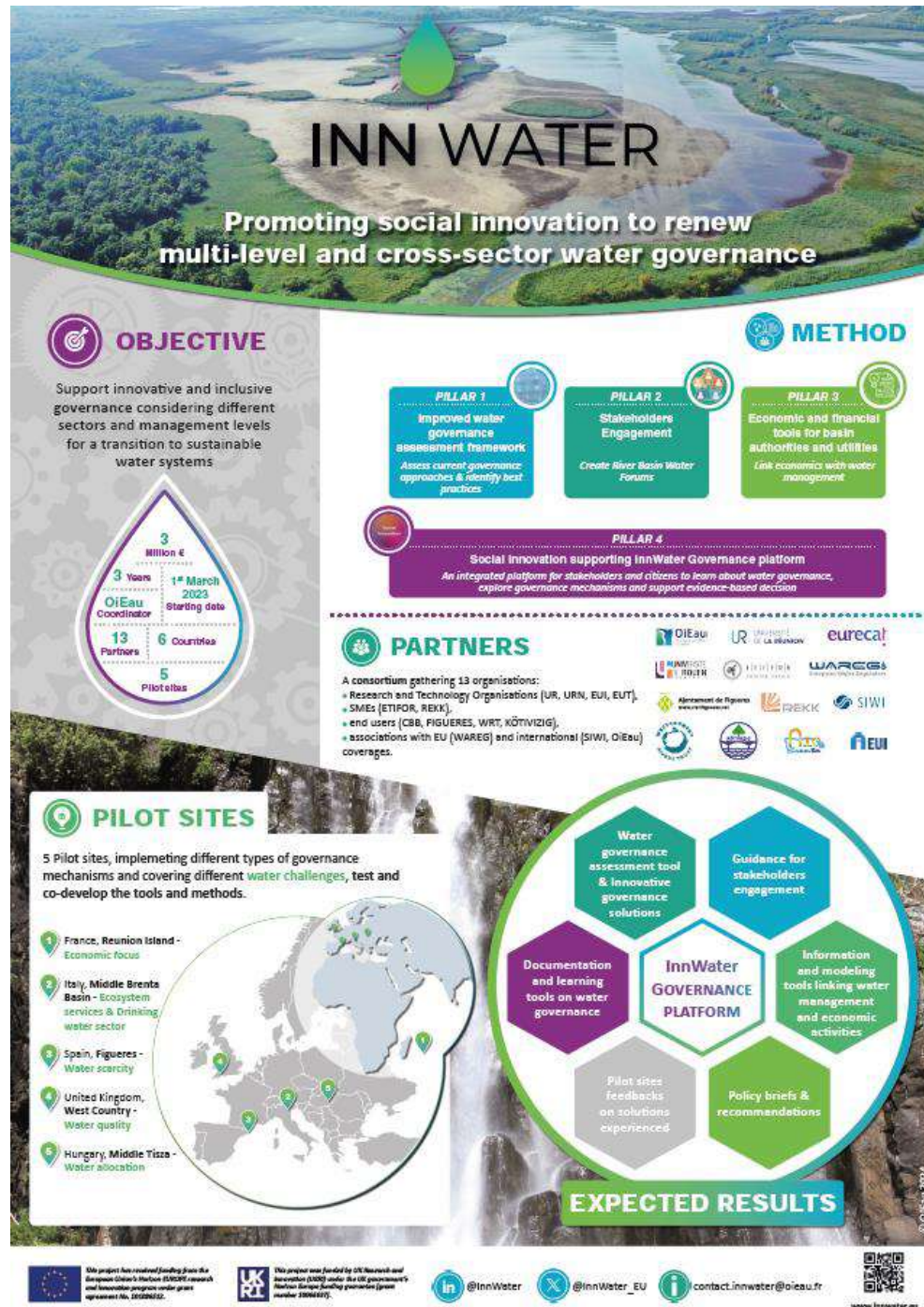


Figure 5: InnWater poster – Final version

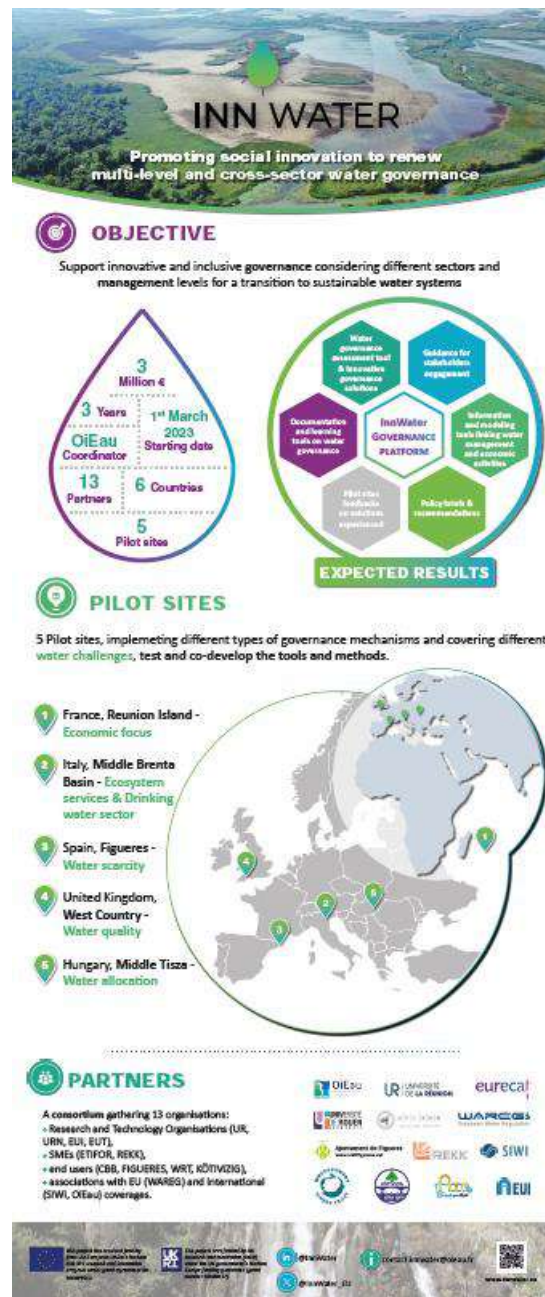


Figure 6: InnWater roll-up

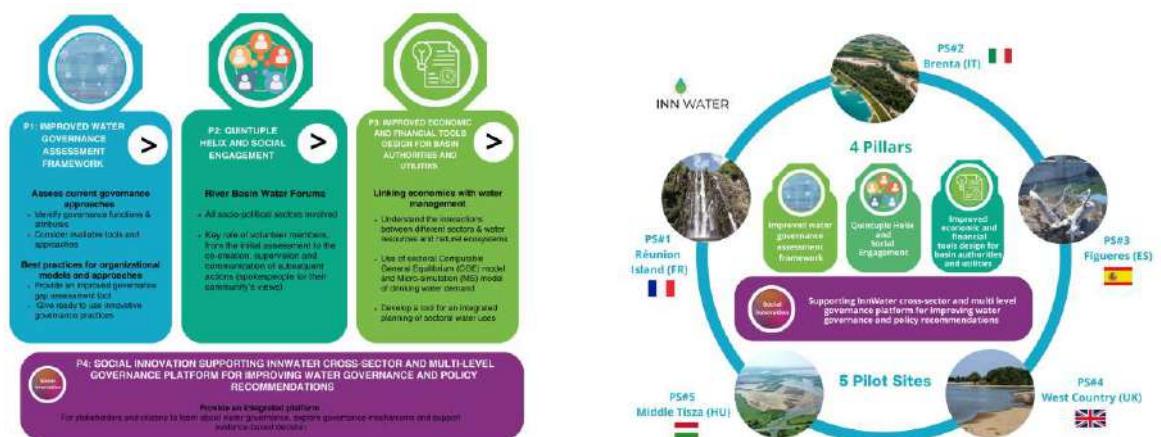


Figure 8: Diagrams

- Need of **investment in infrastructures**

3. ACTIVITIES RELATED TO THE EXTERNAL COMMUNICATION

The external communication aims at reaching stakeholders of the project. The materials created (logo, leaflets, posters, etc.) are used, as well as the project website and social media (LinkedIn and X (Twitter)) to share news and outcomes of the project. The networks of the partners involved in InnWater are also mobilized to communicate and disseminate on the project's progress and results, as well as other EU initiatives. The following sections present the deliveries made over the first period of the project.

The main communication activities can be found in Annex 1.

While implementing these activities, InnWater partners paid a particular attention to use inclusive language and communicate without using gender stereotypes, both orally and in writing. The second version of this deliverable will provide feedbacks on the implementation of the InnWater Gender and Social inclusion chart³ on the C&D activities, and more generally on some activities of the project.

3.1 InnWater visual identity

3.2 Website

The project website www.innwater.eu is used for communication and dissemination activities. News and event are regularly updated, as well as the Media center page.

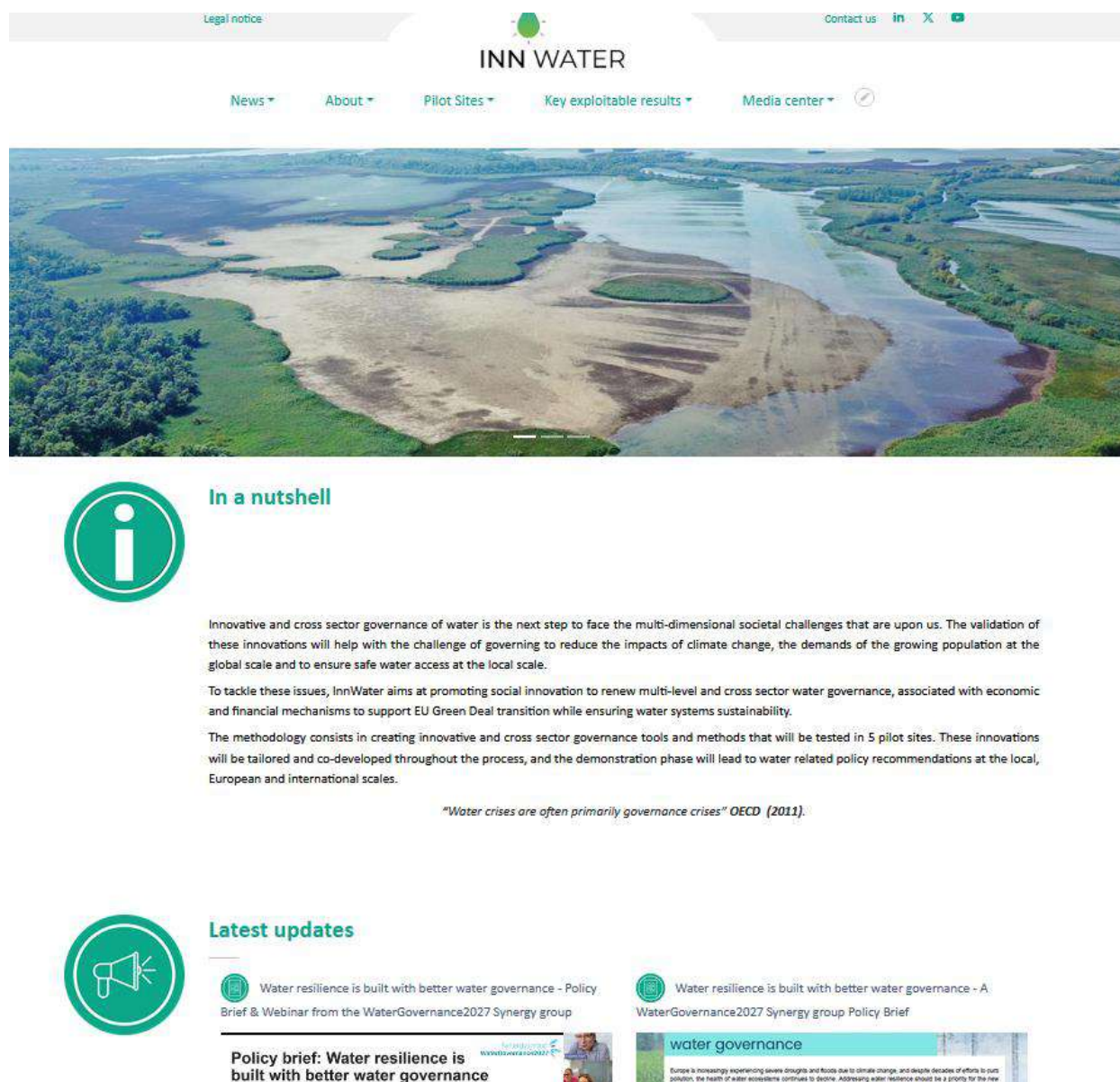


Figure 10: InnWater website

Since the opening of the website early September 2023, 1130 people visited it, with an average duration of 3 minutes. Documents were downloaded 131 times.

10 News and Events were created, and 7 Project articles published.

3.3 Social media

InnWater accounts were created at the start of the project for both X (Twitter) and LinkedIn, the last one being a particularly relevant channel these last years for sharing news on technical and research projects.

News is posted every week on each media.

LinkedIn can also be the place to engage in some discussion with experts, asking for opinions and reaching a large panel of external stakeholders. LinkedIn is becoming more and more the reference tool to discuss about project with a large panel of stakeholders. OiEau is the administrator of InnWater account.

On 15 August 2024, 381 people had subscribed to the InnWater LinkedIn page.

99 posts were made on InnWater's LinkedIn page (see Annex 4).

Since August 2023, 559 reactions to the posts and 16 republications have been recorded. Posts were seen 13 676 times.

X is used for short messages (maximum 280 characters) mainly for live information like events. OiEau is the owner of the account.

On 15 August 2024, the InnWater accounts had 51 followers.

92 posts were made on InnWater's X page (see Annex 4).

3.4 Webinars

Pilot Sites ran webinars, workshops or meetings related to their topics, context and objectives (see Annex 3 for more details). The overall aim is to ensure the results delivered by the project are well aligned with the needs and expectations of the local stakeholders gathered in the 5 pilot sites. Called "local webinars", they are under the responsibility of the Pilot Sites leaders with the support of WP5. 12 webinars were held since the beginning of the project.

Complementary to the Pilot Sites webinars and meetings, transversal webinars are held with all the 5 Pilot Sites, gathering some Pilot Sites communities' stakeholders, Pilot Sites leaders and InnWater partners from other WPs. The first of these webinars was held on November 2023, to introduce the project and discuss with all the stakeholders on their water governance challenges

and expectations. The second time was dedicated to the presentation of the work on water governance assessment realised by WP2.

The webinars organized by the synergy group are detailed in part 5.1.2.

3.5 Events

InnWater was presented at several events, especially:

- the National Technical Group on the Sub-basin Management Plans (France) on 6 June 2023 (online). The project was introduced, and a time was dedicated to exchanges and discussions on water governance challenges and needs from French water managers.
- the Annual meeting of the Tisza Sub-basin Water Management Council on 8 November 2023, in Hungary.
- the CASSANDRA bi-annual conference, organized by our partner EURECAT, intended to propose scientific, technological and socio-political answers to the effects of these crises, in Africa and the Mediterranean. The event was online and split in different panels. InnWater was presented in Panel 7 dedicated to « Data to Action », on 14th November 2023.
- the Europe-INBO International Conference for the Implementation of the European Union water directives, held in Valencia, Spain, on 18 October 2023. Here the workshop was organized by the WaterGovernance2027 synergy group and aimed at supporting basin managers and other stakeholders in finding new ways to tackle water governance challenges.
- a EU Green Week Partners Event “Sustainable Water Governance: Insights from InnWater and beyond”, organized in the frame of the Second physical general assembly of the project, held in La Réunion. On Wednesday 5 June 2024, the University of La Réunion (UR) and International Office for Water (OiEau) organized a 4 hours event to exchange on water governance challenges and solutions between Pilot Sites leaders coming from several European countries, La Réunion local stakeholders coming from different sectors (water and sanitation services, agriculture, food, health, industry, natural areas, civil society, citizens, policy makers, researchers), and partners from Southern Africa region.
- the World Water Forum in Bali in May 2024, during a session dedicated to water governance.
- the Conference of the Hungarian Hydrological Society, in July 2024, in Hungary.

The partners also communicated about the project during several events, through presentation in meetings, oral presentations in conferences, display of the project poster and interviews. They also wrote articles presenting the project or highlighting activities lead in the context of the project.

5. ACTIVITIES RELATED TO THE CROSS-CUTTING STRATEGIC LAYER

The cross-cutting strategic layer ensures that the C&D activities deliver useful and targeted messages and contents. In practice, it consists in being proactive to create awareness on the topics related to InnWater, liaise with other initiatives and pave the way for useful InnWater products and services.

5.1 Linking with partners own initiatives and networks

Our partners make InnWater live also through exchange and collaboration with other projects and initiatives.

- The International Network of Basin Organizations (INBO) is working towards the promotion and support of Integrated water resources management in national and transboundary river basins, lakes and aquifers. InnWater and INBO then share some common interests and target the same type of stakeholders. As explained earlier in this document, the INBO annual conference was used to present the three projects of the synergy group, and permanent exchanges and discussion are held with INBO project managers. A call for case studies (under task 2.2) was also shared through the INBO network.
- Since OiEau is a partner in the Water4All project, especially in the Science-Policy-End-users interface, links are also made with this project on a regular basis. Water4All aims at enabling water security for all in the long term through boosting systemic transformations and changes across the entire research – water innovation pipeline, fostering the matchmaking between problem owners and solution providers. It brings together 90 partners from 33 countries, for seven years (2022-2029).
- Some of our partners also have links with the OECD, helping the project to work in coherence and complementarity with them (for example regarding the work of OECD on the local implementation of water governance principles).

Beyond these specific networks, partners have their own water governance challenges, history, solutions and remaining problems. This is of particular interest in the project, since it can lead to exchange of ideas and feedbacks inside the project (during WP meetings, general assemblies or project events), but also with external partners (the EU Green Week Partners Event 2024 was for example the opportunity for fruitful discussions with external partners on water crisis and water governance challenges).

By assessing the feasibility and constraints of InnWater solutions in new locations, the work on replication will also feed exchanges across Europe on water governance.

5.2 WaterGovernance 2027 Synergy group

The **WaterGovernance2027 Synergy group** gathers InnWater, RETOUCH NEXUS and GOVAQUA, all funded by the CL6-2022-GOV-01-06 of the European Union's Horizon Europe Research and Innovation Programmes.

The synergy group is organized around 6 task forces, task force 4 being dedicated to the communication.

The logo of this group was created by OiEau, who has participated in several meetings. These meetings are the opportunity for partners to discuss coherence and common activities within the three projects.

Some challenges may arise, like making all the results of the project easily accessible, allowing for their Dissemination. The co-creation work, inside the project and with the Pilot Sites Communities, as well as the Exploitation roadmap, will serve as a strong basis to succeed in this task.

The figure below (Source: <https://www.hydroinfo.hu/en/ho/hvkgrafikonok.html>) shows that the accumulated snowpack in the Tisza catchment is now close to its all-time minimum. The likelihood of spring flooding due to rapid snowmelt has been low this year, but the lack of snow accumulation is also a warning sign of low replenishment of water reserves in soil for the summer. 💧
REKK and KÖTIVIZIG will analyze the consequences of increasingly frequent droughts in the pilot site, the resulting water allocation challenges and how economic policy instruments can be better integrated into #watergovernance.



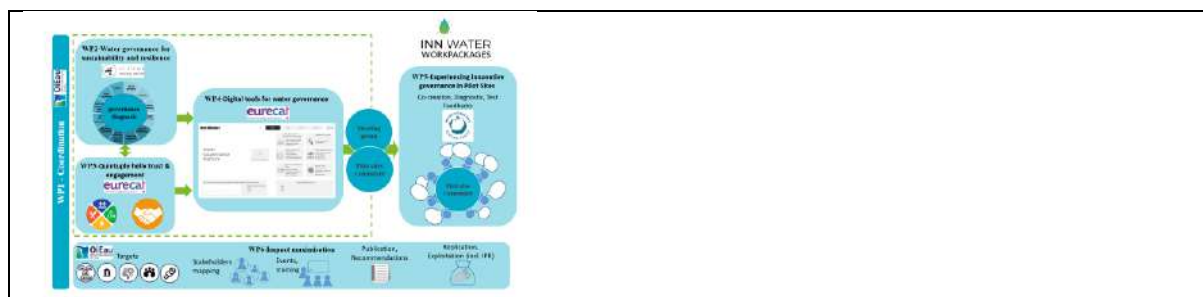
